The lobbying effort has involved, at various stages, support from H.M. Foreign Office and from the Bank of England in raising the issue with their counterparts in the U.S. The U.S. Administration has accepted the merits of the arguments raised, but has not yet succeeded in persuading certain key elements of the legislature.

Our U.S. advisers believe your support would be very valuable in reinforcing the position of the Administration, and the British Ambassador's staff have indicated to Secretary Baker's staff that the issue may be included in the Agenda for your talks with him. SUMMARY

1. THE BANKS' LAWYERS NOW CLAIM THAT KEY MEMBERS OF THE HOUSE FOREIGN AFFAIRS COMMITTEE HAVE AGREED TO RECOMMEND TO THE COMMITTEE THAT 104E SHOULD BE AMENDED AND THE OFFENSIVE SENATE LANGUAGE REMOVED.

DETAIL

2. CONGRESSMEN FASCELL (CHAIRMAN, HOUSE FOREIGN AFFAIRS COMMIT-TEE), SOLARZ (CHAIRMAN OF ASIAN AND PACIFIC AFFAIRS SUBCOMMITTEE) AND LEACH (RANKING MINORITY MEMBER OF THE A & PA SUBCOMMITTEE) HAVE APPARENTLY REACHED A DEAL WITH THE BANKS. PRESIDENT SOLII OF PALAU AND THE STATE DEPARTMENT HAVE ALSO ACCEPTED. THE DEAL. 3. THE FOREIGN AFFAIRS COMMITTEE WILL MARK UP COMPACT ENABLING LEGISLATION ON 27 APRIL. THE 3 CONGRESSMEN WILL RECOMMEND THAT THE ORIGINAL 104E (THE COURT STRIPPING PROVISION) BE REMOVED FROM THE LEGISLATION AS PRESIDENT REAGAN REQUESTED. THEY WILL SUGGEST THE SUBSTITUTION OF THE SENATE VERSION OF 104E BUT WITHOUT THE PROVISION REQUIRING PRIOR NOTIFICATION BY THE PRESIDENT OF PALAU OF ANY INTENTION TO USE COMPACT FUNDS TO REPAY THE DEBT TO THE BANKS (SEE MY TELNO 794).

4. PALAU CAN THEREFORE REPAY THE BANKS WITH THE CAPITAL ACCOUNT AND PART OF THE CURRENT PAYMENTS FOR ENERGY. THEY CANNOT USE THE BULK OF THE CURRENT ACCOUNT. THIS IS SLIGHTLY AWKWARD SINCE ANY SETTLEMENT WITH THE BANKS IS LIKELY TO USE UP WELL OVER HALF OF THE CAPITAL ACCOUNT FUNDS. THE BANKS HAVE ACCEPTED THIS BUT RESERVE THE RIGHT TO REOPEN THE ISSUE.

5. THE REMOVAL OF THE PRIOR NOTIFICATION PROVISION MEANS THAT THE BANKS, IF THEY GET A FAVOURABLE COURT JUDGMENT, COULD ASK THE NEW YORK COURT TO ATTACH COMPACT FUNDS. THIS IN TURN WILL ENCOURAGE PALAU TO NEGOTIATE A SETTLEMENT. THE BANKS WILL RESUME NEGOTIATIONS AFTER MARK UP. COMMENT

6. THIS IS REMARKABLY GOOD NEWS FOR THE BANKS PROVIDED THE FAC LIVES UP TO THE AGREEMENT. STATE DEPARTMENT APPARENTLY PERSUADED SOLII TO AGREE BY THREATENING TO DELAY THE COMPACT. HOWEVER, THE BANKS ARE NOT OUT OF THE WOOD YET. THEY HAVE TO GET THROUGH THE HOUSE INTERIOR COMMITTEE AND THEN PERSUADE THE SENATE, IN



Thank you for your letter of 13 April about developments in the US Congress affecting the debts that Palau contracted in respect of the construction of its electrical power plant.

Your letter unfortunately was sent only after the Chancellor had seen Secretary Baker at the Spring Meetings in Washington. We understand that the most recent developments in the House of Representatives have been encouraging, and that the banks will resume their discussions with the Palau authorities. We shall up the necessary pressure on the US continue to keep administration to make representations in the Congress so as to allow Morgan Grenfell and other creditors the right to pursue their legitimate claims for the recovery of Palau's debts.
